DIRECTOR'S CUT

Summer is in full swing and we have several projects underway in the library. We also very excited because we are expecting a new addition to our staff! Okay, not really a new addition, but a new baby! Erin is expecting and due in August. While we are thrilled for her, we will miss her while she is on maternity leave from now until January 2020.


Currently, the largest project we are working on is reviewing each title in the classified material section of the library, well over tens of thousands of titles. This is called 'shelf reading' as we are literally checking every shelf for every title we own. We are donating and/or recycling most 2nd, 3rd and yes, sometime 4th and 5th, copies of material. We are evaluating older, out-of-date material and deciding whether if it falls into our mission, keeping in mind we are a research library. We factor in several criteria: if the material is available online, and if so, how easily accessible it is online; and whether or not it has ever been used. Next, we are making sure everything is in call number order and marking titles "missing" in the <u>catalog</u> if it is not checked out or not on the shelf. Figuring out the missing titles will be our next project!

As we are working through the collection, we are signifying California (KFC) material on the end panels in blue lettering while the American Law (KF) and all other classification codes are noted in black lettering. We are also making use of the entire range of shelving, from top to bottom. This will allow us to remove several shelving ranges on the West side of the library to make a new comfortable reading/break area in front of the doors to the West Atrium. This should be done by October. If you haven't seen it, please come and stop by! Finally, if you have any trouble finding a title, please ask any staff member.

STAFF HIGHLIGHT - JAN GROSS, LAW LIBRARIAN

LEGISLATIVE HISTORY UPDATE: BROWN GOVERNOR CHAPTERED BILL FILES NOW AVAILABLE

An important piece of any legislative history that we compile is the Governor's Chaptered Bill File ("GCBF"). The GCBF is a file maintained by the Governor's Office for each legislative bill signed into law (i.e., chaptered) or vetoed. These files typically contain analyses prepared by the Legislative Counsel, Attorney General, other constitutional officers, state agencies or the Governor's staff. They may also include correspondence from the bill's author as well as affected organizations and individuals.

Because GCBFs are not available for a sitting governor, for the past several years we have only been able to access them for bills signed into law through 2010. Recently, however, we learned from the State Archives that GCBFs from the last Brown administration are now available on an individual bill basis. Because each bill file must be reviewed and redacted for state agency employee information, we are not able to purchase the entire set at this time, but State Archives staff will do this on a case by case basis as they receive our requests.

WHAT THIS MEANS FOR LEGISLATIVE HISTORIES

In short, there is much more information available for 2011-2018 bills! In terms of process, when you request a new legislative history for one of these bills, we will ask if you would like us to request State Archives materials, which will now include a GCBF. Additionally, if you request a legislative history that we have previously compiled, we will ask if you would like us to update it with a State Archives request. As always, these requests typically take about three weeks, although we have seen quicker turnaround times lately.

For recent bills there is, of course, legislative history information readily available on Westlaw/Lexis and <u>LegInfo</u>. But when you need to dig deeper, remember that there may be more information out there, and your Reference Librarians can help you find it!





EARLY MINUTE BOOKS AT THE CALIFORNIA STATE ARCHIVES
AND THE CALIFORNIA JUDICIAL CENTER LIBRARY



Minutes of the Supreme Court of California, 1850-1851

Bound in oversized volumes, the earliest minutes of the Supreme Court are housed at the California State Archives in Sacramento. Volumes A–G, as described in the <u>Inventory of the Supreme Court of California Records</u>, contain minutes from the organization of the court in 1850 through 1863. Volume A, which includes an entry for the court's first proceeding on March 4, 1850, was digitized by the State Archives in 2016.

Prior to 1911, records of the Supreme Court's orders and proceedings were maintained in handwritten minute books. Frequently kept by office or department, overlapping entries and duplication of dates between the volumes at each of the Supreme Court's three offices were common. Even after 1911 when the practice of keeping typewritten minutes, bound in consecutively numbered volumes, began, some handwritten volumes continued to be created. Early minutes of both the Supreme Court of California and the California Court of Appeal, First Appellate District, can be found here at the California Judicial Center Library. These records typically duplicate the holdings of the California State Archives. The earliest example housed in Special Collections & Archives contains the minutes of the Supreme Court of California for the period 1878–1880.

CONTINUING EDUCATION:

VITA ISYANOVA ON AASLH'S BASICS OF ARCHIVES COURSE

The newest member of CJCL's Special Collections & Archives team, Vita Isyanova, is currently enrolled in an online course designed to provide an introduction to the core aspects of managing and protecting archival collections. Vita says:

As I take the 'Basics of Archives' online course from the American Association for State and Local History, I understand, more and more, how unique the collections we have in our Special Collections and Archives Department are. Also, the more I learn from this course the more I see what an amazing and dedicated staff we have who is willing to teach and share knowledge.

The course I am taking is designed for people who might have some experience or very little, like me. A lot of the participants are working in museums or university archives and none of them have collections as wonderful as we do.

Now that I have almost finished the course, I realize that the most interesting part of it has been the topic "Acquiring Your Collections". In this topic we focused on how vital a collection policy is--it provides the boundaries for the kinds of material you will collect. Also, learning how to appraise material is very important.

I hope that by the end of the course I will have learned enough to be able to apply the knowledge to processing and taking care of our unique collection of papers and memorabilia from past and present California Supreme Court Justices.

Notes & News from Collection Management Services

A Tip on Viewing Catalog Records

We share our catalog with the other libraries of the Court of Appeals in Districts 2, 3, 4, 5, and 6. This means that we also share our records!

Our holdings (individual copies or volumes) display in numerical order by district, from 2nd to 6th. The CJCL copies appear *after* all of the other districts' copies.

If you've ever viewed a catalog record and had trouble identifying where our copies are located on the page, see the example below from <u>California Practice Guide</u>: Family <u>Law</u>:
